Since Christmas break, 10 staff members have reported that they have COVID. Making preparations for COVID vaccine; we are getting information and will encourage staff to get vaccinated. We are waiting to see if vaccine will be required sometime in the future. It is expected we will remain Virtual until the fall.

## **Director of Operations Report:**

Sis-Obed reiterated responses around COVID and safety concerns.

Building construction fell behind schedule due to the initial COVID shutdown by Gov. Wolf, but construction is on pace now. Expect building to be ready in May.
